The Gerontological Society of Serbia (GSS) is inviting you to

X NATIONAL GERONTOLOGICAL CONGRESS, WITH INTERNATIONAL PARTICIPATION,

Which is held 18 and 19. May 2018. in Belgrade (Sava Center), Serbia

The theme of the Congress is:

AGING AND HUMAN RIGHTS

Participants of the Congress will analyze the latest views on age and aging, as well as the state of respect for basic human rights and fundamental freedoms of citizens in the world, based on the basic documents of the UN, the Council of Europe, the Constitution of the laws of individual states. The goal is to look at all aspects of the position of older citizens, as well as the attitude towards the elderly, and to provide appropriate contribution in the conclusions and proposals to the development of international and national policy of aging and everything that helps the elders in their everyday life.

The program of the Congress, in accordance with the modern gerontological approach, is multidisciplinary and holistic. Presentation of scientific and professional publications and posters in the fields of law, economics, philosophy, sociology, demography, medicine and rehabilitation, social policy and social work, psychology, pedagogy, religion, culture, architecture, urbanism and housing issues, physical culture, ecology, rural development, consumer protection and all scientific and professional disciplines, as well as volunteer humanitarian activities, dealing with aging issues.

Bearing in mind the general topic of the Congress in the GSS, we believe that all scientific and professional press releases and posters should be focused on different aspects, and primarily in the practice of respecting human rights in all areas of the elderly population.

In this sense, in addition to the plenary opening speeches, planned and special sessions:

- scientific research activity in the gerontological field
- socio-economic and anthropological,
- geriatric-medical with emphasis on patient's position
- sociological and psychological,
- social-gerontological and socio-political,

- social - ecological, rural, urban and architectural,
- socially humanitarian with a focus on the role of CSOs (the HumanaS network)

We are sending the first call for applications for scientific and professional press releases and posters that would be presented at the Congress, lasting up to 10 minutes.

Deadlines:

- A summary in English until 31 August 2017.
- Text as a whole in English until 28. February 2018.
- Poster Presentation until August 31, 2017.

The official language of the Congress is Serbian, and for foreign guests a translation into English will be provided.

The Congress is licensed for employees in health and social care, as well as for teachers.

INSTRUCTIONS FOR THE PREPARATION OF ABSTRACTS AND PAPERS

The program for preparing the text and tables is Word for Windows in Times New Roman 12 point font.

Abstract: Serbian and English – up to 300 words ,
Key words maximum of 5.

The author's scientific title and his/her name and surname: Times New Roman 12 point font, italics.

Employer, country and email address

Paper: 10 pages, including the abstract in Serbian and English

The paper should be written in A4 format, where the left, right and top margins are 2.5 cm and the bottom margin is 3 cm.

Paper title: Times New Roman 12 point font, bold, centred.

The author's name and surname: Times New Roman 12 point font, bold, centred.

Employer, country and e-mail address: Times New Roman 12 point font, bold, centred.

The text of the paper

Chapter title: capital letters, Times New Roman 12 point font, bold.

Subchapter title: Times New Roman 12 point font, bold.

Text: Times New Roman 12, justified.

When structuring their papers, authors should adhere to the IMRAD methodology (Introduction, Methodology, Results and Discussion, meaning that the paper should be divided into the following parts in terms of its content: introduction, methodology, results, analysis and, finally, discussion or conclusion).

When citing sources in their papers, authors should mention the first and second author as well as the year of publication (Novak in Smithers, 2006) or the first author and 'et al.' in the event of three or more authors (Zigler et al., 1991).

There should be a space of two lines between the text of the paper and the mention of sources. The list of sources should be in an alphabetical order according to the surname of the first author. *The list should only include the sources to which you refer in your paper.*

Abram, J. (1996). Title of the paper. Title of the journal, Vol. 31, No. 4, pp. 231-239. – Times New Roman 12 point font.

Novak, J., Smithers W. (2006). Title of the book. Place: Publisher.

Zigler, J., Norton, P., Leonard L. (1991). Title of the conference or the chapter of the book.

Title of the book or title of the conference (location, date of the conference, C.M. Burns, (ed.). Place: Publisher.
